REFLECTION



As I sit here reflecting on 2021, a full year of pandemic living, I first want to say "I miss you". 

CLARKSON CONNECTS



2021 continued the Covid saga that started in 2020. Vaccines, restrictions, lockdowns, variants are all words that were used way too often and impacted the way we lived our lives. But through this all CRPC continued our mission to provide for the less fortunate through our Compass ministry. The Compass had another interesting year. We continued to reinvent the way we deliver services to our vulnerable population, honoring the resources that have been put into our trust by the members of CRPC.

OPERATIONS

Our makeshift online market has been reimagined making it a seamless experience for the clients. We renovated our website making it more accessible

and easier to use to our client population. We did this by making it more mobile friendly, as most people visit our site from their phones. And, by adding in a translate feature that translates the content of our website into over 40 different languages making it easier for our clients who have difficulties speaking English.

AWARDS

The Compass was recognized in 2021 as one of Charity Intelligence's top 10 Canadian Impact charities and one of their top 5 Toronto Charities. The Compass demonstrated high impact and from their calculations have 96 cents of every dollar going to the cause. PROGRAMS

While we have continued to have a limited number of non-market related programs, God has given us the ability to continue to provide our Refresh program, which provides a space for clients to discuss religion and worship. We received a technology upgrade grant which we used to get loaner tablets for our clients who participate in the program.

We launched a reconnect program on Thursdays on zoom, to reconnect the sense of community that some of the clients have lost over the last year. We encourage everyone to participate. If you would like to log on and listen to what is going on, then simply rsvp to community@thecompass.ca

MOVE AND BRANDING

In anticipation of our 2022 move, the Compass spent 2021 observing the work on the Indwell building. While many building projects suffered shortages and delays, God provided for the Indwell team so that the delay in our new location was only postponed by slightly over a month. Our plan remains t be in and fully operational in the new location by March of 2022. The building is almost complete, and a picture is included below. With the new location we also had the opportunity to rebrand. As such we launched a new logo and new colors, moving from a maroon and mustard to a red and wheat color.



CRPC


Once again, through this tough year CRPC has given out of the kindness of our hearts. Even as covid continued to complicate our lives, we raised over \$750 for the Compass Walk this year. In 2020, through the help of the Faith -In-Action group we provided birthday bags for children at the Compass. This was greatly appreciated with parents commenting on how much joy these bags brought to their children. This year, with guidance from the Faith in Action team, CRPC continued this tradition by providing over 60 birthday bags. CRPC's drive through food drives were also greatly successful in helping us fulfil our mission to feed the hungry in our community.

Evangel Hall Mission

Refugee Response

The Al Rmidian family continues to thrive here in Mississauga. Both Alia and Hussein have been employed throughout the pandemic. They are both regarded as key employees in their respective workplaces.

The children are also doing extremely well in their schoolwork. Malak is in grade 10 while Mohammed is in grade 9, both at Lorne Park Collegiate. Mariam is in grade 7 at Hillcrest Middle School, while Mahmoud is in grade 2 at Whiteoaks Elementary School. All of the kids have grown taller and matured immensely in the last year. Mohammed is now quite a bit taller than his parents!

May 26th was a date of immense pride for the family as they took the oath to become Canadian citizens. Unfortunately, Covid protocols prevented us from seeing or celebrating the online procedure.



Fortunately, we did get to congratulate them in an outdoor gathering on the church patio in July. What a pleasure it has been for us to see them learn and develop and succeed.

The only negative experience we've had is something beyond our control. Three years ago, we applied to bring Hussein's younger brother, Mahmoud, to Canada. Then Covid hit and although the application has been approved, he is still in Lebanon. Along with Christ First United Church, we are now in the process of considering sponsoring an Afghan family whose story

has come to our attention. More information should be available by March.

Faith in Action

Our Faith in Action initiatives for 2021 continued to be challenged by the continuing and ever changing restrictions due to the Covid-19 pandemic. Our church community responded to these challenges, and throughout the year the enthusiastic support for each of the outreach initiatives helped to shine God's light and message of hope in our neighbourhood.



We held a **drive-thru food drive supporting Compass clients** in the spring and repeated it again in the fall. Many thanks to those that supported the food drives and to the volunteers that greeted and also delivered the food collected to Compass.

What began as donations of gift cards to the Arise ministry in the spring, became a move

to monetary donations due to further Covid restrictions. In total we **delivered to Arise \$1,575 in gift** cards and cash.

Compass clients love our "Birthday in a Bag" kits, and we heard from them that they were low in stock and would we consider doing them again. They asked and did we ever respond! Between the cash that was donated and the completed bags that came in, we were able to provide sixty (60) bags!





New in December was our **outreach to Indwell and "The Fresh Start Project"**. Indwell is a Christian charity that creates affordable housing communities that support individuals seeking health, wellness and belonging. Located in Port Credit the residence is due to open in January. Fifty-six (56) welcome bags were created containing items such as paper towels, toilet paper, Kleenex, dish soap, hand soap, tea towels, and a

chocolate treat. Your monetary support also allowed us to add extra items for the twelve

(12) bags made for "The Fresh Start Project". Individuals moving into these twelve units are transitioning from a shelter environment to a home. Cleaning products, mops, brooms, dustpans, toilet brushes and dust busters were added to these twelve bags. Delivery of the bags which was scheduled for early January has been moved to February as the building is not ready yet for occupancy.



Thank-you for your enthusiastic support of Faith in Action this year. With your help through ongoing challenging times, we continue as a community of faith to share the message of God's love and to shine His light in our neighbouring communities.

BUILDING COMMUNITY

Building community, both inside and outside of the congregation, is important as we move into our future. There are many opportunities to build connections with those who are part of the Clarkson Road family. You'll see that the 4th Clarkson Scout Group continues to be an integral part of the Clarkson Road community.

4th Clarkson Scout Group

4th Clarkson Scout Group continued to serve the youth of Clarkson despite challenging operating conditions due to COVID. Our focus in 2021, to be succinct, was to "re-establish" all Four Sections of Scouting at 4th Clarkson in the Fall of 2021. By the end of the Spring 2021 Season (June 2021) youth had lost interest in "online" so the challenge was to "bring us back" to "in-person" adventure and programming.

We were able to restart the Beaver group in October of 2021 which had been suspended, Cubs, Scouts and Ventures this year are essentially "over-subscribed". We maintain limits on youth numbers we can manage until we can ramp up and return to normalcy of operations.

Through the dedication of our volunteers, and the addition of some new volunteers (Scouters), we have good staffing levels for our current youth cohort. What we are finding is, as 1st Clarkson has suspended operation and 3rd Clarkson is struggling, we are getting more inquiries than we have capacity. The experience of Scouting here is no different than in many areas of Community and Outreach programs, "too few volunteers willing/able to commit time"...sound familiar?

CRPC continues to sponsor youth who require funding to participate and we have one applicant in process at this time under this program.

Fundraising has moved online for Scout Popcorn and Scout Coffee however we are looking at a late Spring Bottle drive as a method to replenish our Treasury for which we have been dipping slightly into our reserves, albeit at a modest pace as many of our larger expenditure camps were not offered in 2021.

CAMPING

On this front we loaned equipment to Scout Families in the summer of 2021 who wished to do their own camping in their defined social bubble. We feel it is important to keep the youth engaged in camping and the outdoors and not have them fall behind as clearly we did not open up in the summer of 2021 the way we might of hoped.

MEETINGS

Online Zoom meetings are used to some degree however most people have enough of this in their "diet" so these are used mostly as planning sessions. Real engagement comes from real interaction and that is outdoors, or for a period in the Fall of 2021, indoors.



NEW CHAIRMAN

We work to promote engagement at all ages and experiences. As an example of this we recently bought Gord Williams into a special position as Chairman of 4th Clarkson working with the Group Committee. From his home in the Walden Retirement Centre he provides us with sage advice and counsel. Gord is a young 88 year-old! He also participated in our Tree Planting event with the City of Mississauga in October 2021.

We continue to paddle, hike, bike, swim, plant trees, craft, explore, climb and assist those in our community, building something great for our youth. Something to carry them forward.

We have been fortunate that Sara Joy has been able to provide us with excellent music for the services. There was a short period of in-person services, which were also live-streamed. Live streaming required training in running the Audio-Visual system.



Pastoral care programs continued to ensure that we kept in contact with members of the congregation. Rev. Gale invited members to come and chat with her on the patio at the church. The COVID restrictions have made it difficult to meet with members and to keep in touch with their needs, and these chats offered a welcome opportunity to actually see and talk to people. Faith in Action ensured that we continued our outreach support of the Compass and other mission programs, such as Arise Ministry. For Evangel Hall we were not able to host a dinner but provided a cash donation in lieu of the dinner.

In June, the General Assembly (GA) for the Presbyterian Church in Canada (PCC) made two changes to church law when the following motions were passed.

The Presbyterian Church in Canada holds two parallel definitions of marriage and recognizes that faithful, Holy Spirit filled, Christ centred, God honouring people can understand marriage as a covenant relationship between a man and a woman or as a covenant relationship between two adult persons. That congregations, sessions, ruling and teaching elders be granted liberty of conscience and action on marriage.

That congregations and presbyteries may call and ordain as ministers and elect and ordain as ruling elders LGBTQI persons (married or single) with the provision that liberty of conscience and action regarding participation in ordinations, inductions and installations be granted to ministers and ruling elders.

At GA a change to term eldership was also made giving congregations the opportunity to decide whether terms will be for 6 years or a shorter time period. At present, CRPC Session has not determined the length of term that best meets our needs.

Prior to the General Assembly, the Session had discussed a report from the Committee on Church Doctrine on Medical Assistance in Dying. The Session had expressed concern that the committee had used the title "Physician Assisted Suicide" for their report. We received a General Assembly remit that had changed the title to, "Physician Assisted Suicide: Medical Assistance in Dying". We have responded that we disagree with the title, and we request that the committee change the title of the report, to "Medical Assistance in Dying".

In 2021 Canada was made aware of a number of unmarked graves associated with Residential Schools. Rev. Gale provided the Session with information on the role of the Presbyterian Church in the Residential School program.

Session was presented with many challenges as we discussed the above issues in terms of our Christian faith.

As St Andrew's, Port Credit, is looking for a new minister we approached them to see if they would partner with us on projects in the area that would show a stronger presence of Christianity in the region. Unfortunately, they determined that their priority is to focus on securing a new minister and may consider partnering when the new minister is established.

We have been made aware of a refugee family that is looking to move to Canada. In this case the family speaks English and there is already funding in place to support their move to Canada. We are looking to partner with another church, so that we can adequately support the family when and if, they move to Canada. This initiative will continue to be explored in 2022.

The Session agreed to hold a visitation and service for the funeral of Evan Smith, the young former member of 4th Clarkson Scouts. Evan was killed in a pedestrian/car incident in Vancouver, where he had moved to start his first year at the University of British Columbia. In holding the ceremonies at CRPC we showed our concern for the family and made all accommodations, so that the family was not faced with any other difficulties at this very sad time.

The property, this year, has been used mostly by our building partners (White Oaks Montessori) and continues to be well managed by Board members Cam Hansuld (outside) and Martin Luymes (inside). Please see the property report for details.

The income from rent is key to our ability to fund property maintenance. A big thank you is owed to Joan McInnes for her ongoing work to manage all of our renters, their contracts and our insurance issues.

The Technology Team investigated video streaming in 2021 and initiated a multi-phase program to introduce cameras and streaming equipment. Although there are improvements needed, the Board is happy with the results of the first phase and want to thank the growing volunteer team for their work to stream to Facebook and YouTube. We look forward to the proposed improvements in internet speed (streaming quality), new projectors and more in Phase 2 (2022).

As outlined in the financial report, we were within 2% of budgeted expenses. Thanks to Bruce Murray (finance) and to Treasurer, Megan McLean, who must be highlighted for her great work dealing with the ongoing COVID complexity and government grant/benefits packages while maintaining the books and paying the bills. She also provides regular and timely updates on our financial status and budgets that are critical to prudent management of our resources.

The Board would like to thank others in the hard working support team:

- ⇒ Karen Perez, our Church Office Administrator, provides excellent support of the church staff, congregation, projects and events including maintaining the website and preparing graphics for weekly online services to help us all communicate. Karen keeps us all in line and we would be lost without her.
- ⇒ Tom Tsimenidis, our diligent caretaker who comes in at all hours to make sure our property is tidy, clean and operational.

Property Committee

The church property remains a strong asset for the congregation and the community partners that share our space. The building and grounds are in good shape and there are no immediate concerns requiring attention.

Wear and tear on the building this past year was minimal due to the COVID-driven decline in in-person activities. Some modest repairs to the gym floor were made (extending the life of this floor a bit longer) and to the plumbing in the accessible washroom.

One unusual set of investments we did have to make involved strategic upgrades to our aging hot water heating system. Some of these upgrades were expected, some were not. Over the past decade, the boilers, pumps and heat distribution system were under-maintained, with virtually no planned maintenance undertaken, and repairs made only when and if necessary. This was not a sustainable approach. Early in 2021, the Board approved bringing in a reliable and reputable local HVAC company to take care of some immediate needs (including delivery of more reliable and controlled heating into the sanctuary) and, going forward, to provide regularly-scheduled service. The upgrades and fixes resulted in higher than usual expenses in this area for the year, but much of this was "catch-up" work and it is anticipated that costs going forward should be more modest.

No major improvement projects were undertaken over the past year.

We are grateful for the reliable and efficient support of our lawn cutting and snow clearing services and we should also acknowledge the assistance of the Scouts and many volunteers who raked leaves and made quick work of what would have been a big job for any one person. We are also grateful for the dedicated service of custodian Tom Tsimenidis and Office Administrator Karen Perez.

PRESBYTERY

2021 continued to be a strange season for the Church, in Canada and around the world, as most congregations were closed to in-person worship for much of the year. Congregations have gotten used to their ministers preaching from their kitchen tables, or their living rooms, or in sanctuaries that echo with vast emptiness. In our Presbytery, most congregations tried to open at some point between Labour Day and Thanksgiving in hopes that it would be permanent, but rising numbers with the Omicron variant shut everything down again around Christmas. Some are hopeful that they will be able to reopen their doors again in February or March, but there is much praying to be done by all between now and then!

Presbytery meetings remained on Zoom, and will continue to be so as we move through 2022. We miss the camaraderie of being able to meet in-person, as well as the casual fellowship we find in the pews or across the dinner table from one another. Our committees continued to struggle with their work for much the same reason – "What can we plan? What can we do?" It is hoped that we can initiate some movement in this area, at least, as we move into 2022.

Our Moderator for the first part of 2021 was Ms. Laura-Lee Campbell, the Representative Elder from St. Andrew's, Hillsburgh. During the latter portion of her tenure, she oversaw the ordinations of the Rev. Candice Bahadoor (as well as her induction into the ministry to the congregation at Heart Lake PC, Brampton), and the Rev. Debora Rolls, who was then inducted into a charge in Peterborough. She then passed the baton of Moderatorship to the Rev. Stephen Mutavdzija, her minister at Hillsburgh!

Several farewells were notable in 2021. Rev. Brad Shoemaker left his position as chaplain at the Maplehurst Correctional Complex early in the year, and Rev. Lydia Bae had officially departed from Heart Lake at the end of January. The Rev. Dr. Andrew Human retired from St. Andrew's, Port Credit, and the Rev. Barb Molengraf retired from St. Paul's, Bramalea. Rev. Harvey Self's retirement was finalized, as was that of Frances Sullivan. Rev. Jen Sokolowsky is resigning from Erindale PC to take up a position at Camp Kintail, and we will have two more vacancies in the Presbytery soon! Our Presbytery could well look very different by the end of 2022.

Rev. Steve Boose is concluding his Master's of Pastoral Studies after four years of part-time study, and the court hopefully has a new student for 2022, Samira Babar. However, as 2021 ends, we have no other active students under the Presbytery's care.

One notable new item for 2021 was the creation of a Rainbow Communion Committee. This was in response to the decision at General Assembly in June to permit congregations to ordain as elders and/or call to their congregational ministry same-sex attracted individuals who are in long-term committed relationships, as well as to permit ministers to perform marriages between "two adult persons" without the stipulation of heterosexuality. The Rainbow Communion of the Presbyterian Church in Canada was intended to allow individuals within the Church with non-heterosexual / non-cisgendered understandings of themselves to have a safe space to express what they have encountered while trying to find Christ among His Christians in the PCC, and with the passage of the Remits, some recommendations intended to start the healing process between the Church and those who have been wounded for their sexual identity have been forthcoming. Our Committee was formed to examine the situation in our Presbytery's paradigm and to suggest ways in which we, as a Presbytery, might move forward in this area to promote healing and reconciliation.

In conclusion, our vacant congregations as of the end of 2021 include Acton (Knox), Almanarah, Claude (Rev. Mary Campbell - Stated Supply), Ospringe (Knox), Port Credit (St. Andrew's), Trafalgar (Rev. Carolyn MacAvoy – Ministry Covenant), and Union (Rev. Bryan Fox - Stated Supply). Please pray for all our congregations as we move into 2022 and whatever this year may bring for all of us!

MINUTES OF THE 63nd ANNUAL CONGREGATIONAL MEEETING SUNDAY, MARCH 7, 2021

The Reverend Gale Macdonald constituted the meeting with prayer.

Annual Reports for 2020 (excluding the Treasurer's Report):

Moved by Martin Luymes and seconded by Ron Sypher to receive, consider and adopt the Annual Reports other than the Treasurer's Report: Carried.

2020 Treasurer's Report Highlights:

Megan McLean presented the Treasurer's report as outlined on pages 27 to 31 of the 2020 annual report. Megan provided a high level overview of the year's receipts and expenditures. \$270,000 was raised from all sources in 2020. It was noted that the timing of our revenue stream was affected by the global pandemic, causing our givings to dip in the first half of the year.

We qualified for government assistance (Canada Emergency Wage Subsidy) to ensure that we could continue to pay our employees. We were also able to assist the Montessori school by applying for the Canada Emergency Commercial Rent assistance program. Under this program the federal government paid 50% of the school's rent for the months of April to June, the Montessori paid 25% of the rent, and our congregation financed the remaining 25% of the rent.

Our overall church expenses were lower than prior years due to the pandemic related church closure.

Bruce Murray moved and Jim Goodwin seconded

that we receive and adopt the Treasurer's Report for 2020: Carried

2021 Proposed Budget Highlights

The proposed budget for 2021 was presented by Megan McLean. Our expenses are expected to increase in 2021 over 2020 as we begin to open up our building after pandemic-related closures. We expect to end the year at a break even level if our revenue levels remain similar to the prior year.

A motion to adopt the 2021 Goal Budget was moved by Bruce Murray and seconded by Maureen Read: Carried.

Many thanks to Megan for her extremely well thought out and insightful presentation on both the 2020 report as well as proposed 2021 budget. Her dedication and diligence in keeping the CRPC financial reporting in good standing especially during 2020 when the pandemic changed the landscape of worshipping for everyone is most appreciated. Megan spent many hours submitting complete and accurate applications for Government subsidies to offset our expenses in addition to maintaining and reporting an accurate accounting of our finances.

Property Report:

With reduced occupancy and suspension of activities during 2020, wear and tear of Church property was minimal. The building remains in good shape and there are no immediate concerns. However, Montessori School made a few minor modifications in keeping with standards imposed by the Ontario government.

Cam and Martin expressed their appreciation for the reliable and efficient support of our lawn cutting and snow clearing services and thanks to the Scouts who raked leaves in the Fall. Thanks also to Tom Tsimenidis for his dedicated custodial services and acceptance of reduced hours then pivoting back to work with additional cleaning protocols required under new guidelines.

For 2021 we are looking forward to a time when we can meet again in person in the Sanctuary. To this end we are engaging the services of Kongats Architects to conduct a feasibility study examining a refresh of the chancel to accommodate both in-

person and online live streaming of our worship The study will take approximately 2-3 services. months to conduct; upon completion we will receive a detailed proposal with options for enhancement of the chancel area; in particular there will be focus on AV requirements and accessibility. Once the information has been received а special congregational meeting will be held to share the results; both Session and Board have provided their approval of this study.

The report was submitted by both Martin Luymes and Cam Hansuld, the Property Team.

Endowment Fund:

Harry Gregg reported that in 2020 the full allotment of funds available from the Endowment Fund for distribution was not utilized mainly due to COVID issues, i.e. facility closures, interruption of activities, etc.

For 2021 a portion of the allotted funds will be used to help support the purchase of new AV equipment for the Sanctuary. Additionally, several tablets have been purchased to provide viewing of online services to those in the Congregation who do not have internet capabilities.

2021 Plans:

Bill Tebbutt provided an update on the status of the Memory Care Project. Unfortunately COVID in 2020 impacted the project; however over the last few months Beckerman has been able to pick up the pace and with new information on hand we are now looking at a revised schedule and scope of the project. The Memory Care facility will now be 3 stories containing 42 units as permitted under zoning permit. Our property has been re-evaluated at a higher amount and upon completion will yield an increased return on our investment. take approximately 3 years as of middle of 2021. Note: The relocation of the parking lot to the front of the building will be undertaken before any construction commences.

Maureen Read presented an overview of Faith in Action activities for 2020. The Leap Year Games Night was the last time we were able to be together before COVID restrictions impacted our lives. However with support from the congregation, we were able to accomplish the following:

- March Break Bags for Compass families (50 bags)
- Purchase of soccer balls for Compass families
- "Drive-thru" food donations drop-off for Compass
- "Drive-thru" toy collection for Compass
- "Thinking of You" bags for Montessori teachers

Plans for 2021 will evolve as pandemic restrictions change and we can look at safely providing support to the community. In the meantime, we will continue to focus on supporting the Compass as well as other worthwhile agencies, i.e. ARISE Ministry and Armagh. If you have any suggestions or ideas for the Faith In Action Team, please reach out to Maureen, Megan or Jean.
